TEAMSTERS LOCAL 2010 NOTICE OF ELECTION AND VOTING INSTRUCTIONS CX BARGAINING UNIT CONTRACT RATIFICATION

A secret ballot election is being held for the contract ratification the proposed 2016-2022 CX contract with the University of California (UC).

The ratification vote is being conducted in person by paper ballot at the Chapter level April 3-14, 2017. Please check the Local Union website for polling dates and locations in your area. Only full-voting members may vote on the new Union contract. Prior to the opening of the polls, all interested members are strongly encouraged to complete and return a new membership application to ensure their voting eligibility.

To vote, you must attend one of the designated polling places at your campus or medical center. Bring your employee identification card with you. The UC has authorized up to 30 minutes of paid release time for each member to participate in the voting process. Hardship requests to vote by mail will be considered by the Local Union on a case by case basis.

INSTRUCTIONS TO VOTER:

1. In order to vote, an eligible member will be provided an official ballot at a designated polling place. The voter should mark the box on the ballot when answering the following question:

As a Teamster CX member, you will be asked to vote on the following (check only one):

- I accept the tentative agreement
 - I do not accept the tentative agreement. I authorize and am willing to strike.
2. After voting, insert the ballot into the envelope marked "Inner Envelope/Secret Ballot". Seal the inner envelope. Do not put your name or any identifiable marks on the secret ballot envelope. Use of this envelope ensures the confidentiality of your vote.
 3. Place the sealed secret ballot envelope (Inner Envelope) in the envelope marked "Outer Envelope," seal and place in a designated ballot box. The outer envelope must include your full name, employee identification number, work location, signature and date. Outer envelopes not containing this information will not be counted.

ONLY BALLOTS RECEIVED AT THE LOCAL UNION HEADQUARTERS BY 9:00 A.M. ON APRIL 19, 2017, WILL BE COUNTED. In order to have your ballot counted, you must be current in your dues through the month of February 2017, and still be an active member as of 4:00 p.m. Tuesday, April 18, 2017.

The Ballot Count process will take place on Wednesday, April 19, 2017, at 9:00 a.m. at the Teamsters Local 2010 headquarters located in Suite 2010, 400 Roland Way, Oakland CA 94621. Observers are welcome to be present during the ballot counting process. If you have not received information regarding your designated polling place or need to request a mail ballot due to hardship reasons, you may contact the Local Union at:

No person or entity shall limit or interfere with the right of any IBT member to vote, including, but not necessarily limited to, the right to independently determine how to cast his or her ballot, the right to mark his/her ballot in secret and the right to mail the ballot himself/herself. No person or entity may encourage or require an IBT member to mark his/her ballot in the presence of another person or to give his/her ballot to any person or entity for marking or mailing. Any violation of this rule may result in the disqualification of a candidate who benefits from the violation, in imposition of criminal penalties under federal law and/or other consequence or remedy.
